Packages given by donor and shipped in large containers; given also school to children in a hot lunch program; distributes over 2 million meals.

Hope for Kidz Program. Scholarships are given for children to obtain schools in Haiti; children are matched with US donors and funds go mainly to the schools for the childrens education.

Sister Church Program. US churches are matched to a Haitian church. The US church partners with the Haitian church and provides financial and volunteer assistance. Projects include building construction and repair; education and outreach to the community.
